- ELIGIBILITY** Open to those photographers who hand-deliver their work to the Watchung Arts Center on Saturday, October 30<sup>th</sup> from 1pm-4pm. We welcome all photography-based imagery.
- INSTRUCTIONS** Bring your entries along with the completed entry coupons, fee, and a self-addressed /stamped envelope to Watchung Arts Center. Each finished work can be no wider than 45 inches **including** frame. Works *must* be professionally presented, framed and properly wired for hanging. **No clip frames or clips holding the wire.** Any piece larger than 20x24 must have plexi and a sturdy frame. The NJPF, WAC and the CS Hospital are not responsible for work. Artists wishing insurance need to provide it themselves..
- FEE** **\$20 for every 2 pieces submitted.** Checks must be made payable to Nancy Ori.
- DEADLINES** Receiving day..... Saturday, October 30, 1-4pm  
Opening reception..... Sunday, November 7, 1-4 pm  
Pick up of declined work ..... month of Nov only (call for hours, 908.753.0190)
- Show moves to Children's Hospital.....Saturday, November 27, 10am  
Pick up of accepted work.....Saturday, January 29, 10am  
*Everyone must sign for work as it is picked up.*
